

ROAD SAFETY POLICY

Overview

This policy governs the practices required by employees of AEC while driving on business for the AEC. The intent of this policy is to increase the safety of employees, contractors and other road users while driving.

Responsibilities of drivers when driving company's car for official work

All employees, while driving to carry out the work of AEC must:

- Have a valid driving license in the appropriate class for the motor vehicle being driven.
- Follow all rules of the road, as defined in the PDO SP 2000 (Road Safety) and by the Motor Vehicle Act.
- Before moving vehicle, ensure that all passengers in the vehicle wear seat belts.
- NOT operate a motor vehicle after consuming alcohol or other substances (including prescription and non-prescription medications).
- NOT use a cell phone or other portable electronic device while under control of the
- Report any motor vehicle related incident in which they were involved.

AEC commitment to its employees

- AEC will provide a copy of and promote the adoption of this policy to all its employees, contractors and will expect compliance at all times.
- e AEC will not require its employees, contractors to drive under conditions which are considered unsafe and/or likely to create an unsafe environment, physical distress, fatigue, etc.
- All drivers will receive adequate defensive driving training.

Consequences for non compliance

AEC will enforce its Safe Driving Policy with a range of disciplinary measures up to and including termination of employment.

The final decision on the consequences for not complying with the Safe Driving Policy will be determined by HSE Manager in consultation with Contract Manager as appropriate.
